NEW BUSINESS:

1. Proposed Maintenance Dredging and Additional Fender Pile – 16 Harbor Road (Manning). Coastal Engineering Co., Inc. Concerns expressed by the Harbormaster and agreed upon by the Committee members on adding an additional piling would have a negative effect on navigation in an already tight area. The Committee suggested reinforcement of the present pilings which have previously been approved. The petitioner was asked to revisit the suggestions and come back to the Committee with revisions. A motion was made by Dan Hall to table this request till further info is obtained and a revised plan is submitted. Seconded by Kent Druschella. All members were unanimous.

2. Modification of existing seasonal permit for production of Sugar Kelp to include Bay Scallops – Kelleher Farms (Mark Kelleher) Concerns expressed by the Harbormaster regarding the line that would be placed in the water may have a negative effect on navigation. Also, Harwich does not have such areas that could be used. It was suggested that the petitioner consider placing the lines further out and they could go directly to the Selectmen for direction. A motion was made by Kent Druschella to deny the application as presented due to concerns for navigation and location issues. Seconded by Dan Hall. All members were unanimous.
