B. Water Restrictions & Enforcement

The Department just issued \$30,000 worth of citations.

September bills have just been sent out. The Department will have to see what impact the water restrictions have for this fiscal year.

B. Water Capital Plan

Dan provided an overview of the Water Capital plan as well as an update on cost increases.

C. Sewer Enterprise Fund

The MGL states that the Sewer Commissioners oversee the Sewer Enterprise fund. Use of the Sewer Enterprise Fund should not be co-mingled with the Board of Selectmen.
