#### **SENIOR MEMORIAL FIELD FENCING PROJECT**

The Recreation and Youth Commission is requesting \$40,181 for the acquisition and installation of all new fencing at the Senior Memorial Softball Field. This funding would cover all materials, and installation labor for the project.

Senior Memorial Field is one of the premier softball fields on Cape Cod. It is primarily used by the Senior Softball League for their league play in the Spring, Summer, and Fall seasons. It is also used heavily for their annual Senior Softball Classic in September which brings hundreds of people into the Town of Harwich . Senior Memorial Field is also used sparingly for private bookings including family reunion games, company softball games and Recreation Department events. Like Brooks Field, this field's fencing was also evaluated by the entities listed above and was determined to be at the end of it's useful life and becoming a safety issue for players and field users.

This project is an important one for the Town of Harwich as it improves and maintains the status of one of our most prized fields in Town. This will enable us to continue to book Senior Memorial Field to a multitude of users throughout the season. It will also allow us to have great fields for our Recreation programs throughout the year.


