- The undersigned further agrees to provide access, at all reasonable hours, for the purpose of inspection by authorized agents of the Town and agrees to maintain the building sewer at no expense to the town.
- ➤ The Applicant's Engineer, Registered Sanitarian or Installer is responsible for field verifying the location and/or elevation of the lateral prior to work start.
- The septic system shall not be abandoned until the sewer connection is completed and approved, unless prior written approval is received from the Health Department.

Once sewer installation is connected with access to Town sewer, billing will commence on the next billing cycle. Properties on Town water are billed with sewer on a quarterly basis. Both water and sewer rates and fees will be noted on the same invoice.
