

Constitution of the Cemetery connected with the
M. E. Church So. Harwich

- 1st All persons having Lots in the Cemetery may be considered members of this Association —
- 2nd The Officers of this Association shall consist of a Supt., Clerk, Treasurer, & nine Associate Directors, Composed of the Trustees of the aforesaid Church, and such others as they may appoint Annually —
- 3rd It shall be the duty of the Superintendent to preside at all meetings of the Association for the transaction of Business, to assign Lots, & have the general charge & oversight of the ground under the direction of the Board of directors —
- 4th The duties of the Clerk & Treasurer shall be such as usually devolve on these respective Officers —
- 5th It shall be the duty of the Board of Directors, to have the care of the Ground, to enlarge if thought expedient to keep a suitable fence around the ground, and to make such improvements as may be desirable & practicable —
- 6th The meeting of this Association shall be held Annually on the first Wednesday of January, for the choice of Officers and transaction of such other business as may come before ^{them} —
- 7th Special meetings may be called by the clerk, at the requests of five or more of the directors

8th Seven shall constitute a quorum for
the transaction of Business—

9th This Constitution may be altered or Amended, at
any Annual Meeting by a vote of two thirds of the
Members present, proper notice having been given
by the Clerk of the proposed change—

A meeting of the Directors of the Cemetery Assⁿ was held at the call of the President at the Post Office Dec. 10/91 Present, Mrs M. Eldredge, Darius F. Weekes, Wm F. Sears & Obed Nickerson.

On motion it was voted that a com. of one be appointed to get the rubbish cleared from the new ground, and the strip next the fence south cleared of pines ground oaks &c, and the gateway arranged at the southeast corner of the church, and Mrs M. Eldredge was appointed such Committee. On motion, a com. of two were appointed to draw a plan of the new ground, and Mrs M. Eldredge & Darius F. Weekes were so appointed. On motion the meeting Adj^d.

The Annual meeting of the Association was held at the Post Office, Wed. Jan'y 6/92 at One O'clock P. M. The meeting was called to order by the Supt, Wm M. Eldredge. The Sec. not being present, W. F. Sears was chosen Sec. pro-tem.

Mrs M. Eldredge was chosen Supt. for the ensuing year. Obed Nickerson was chosen Clerk & W. F. Sears Treasurer. The following Directors were elected - viz, Darius F. Weekes, Tho. E. Small, Rufus H. Small, Watson N. Small & Mrs M. Eldredge. Mrs M. Eldredge was chosen Sexton.

Voted to choose a com. of two, to draw up resolutions of thanks to Augustus M. Nickerson for the gift of land for enlarging the Cemetery, & Watson N. Small & Mrs F. Sears were appointed.

The report of the Com. on laying out the grounds was

accepted & adopted.

The report of the Treasurer was read & accepted.

It was on motion voted to sell the old fence at Auction, & it was bid off by Eben T. Eldredge for \$1.25.

The Superintendent was instructed to spend what money he thought proper, of what was remaining, for clearing up the grounds.

South Harwich Cemetery Association

And you are directed to post affected copies of this warrant in the South Harwich post office, M. E. Church, and publish in the Harwich Independent at least two weeks before said meeting.

Meeting called to order by William M. Eldredge, and the following business transacted.

William M. Eldredge was elected Moderator
W. F. Pease Secretary.

Article 2nd was next voted on, and thirty six ballots, representing forty seven shares were found cast favorable to the article, and it was so voted.

The following by-laws were adopted.

By-laws of the South Harwich Cemetery Association.

Art. 1 The officers of this association shall consist of a Secretary & Treasurer, and a board of five Trustees, who shall be chosen by ballot at the annual meeting of the association.

Art. 2. The Trustees shall appoint a President & Superintendent. The President shall preside at all meetings. The Superintendent, under the direction of the Trustees, shall have the general care and custody of the Cemetery. He shall keep in books provided for that purpose regular and accurate records of all burials including the name of the person buried also age, and the date and place of burial. He shall have the sole power to engage

and discharge all workmen upon the grounds also to order and arrange their respective duties.

Art. 3. The Trustees shall hold in trust all property of the Corporation and shall have full power to sell burial lots, as the law does or may require in giving title, and defend the same in behalf of the association, and shall fill any vacancy that may exist in any office from resignation, death, or any cause, and shall have full power to arrange the salary of the Superintendent.

Art. 4 It shall be the duty of the Secretary & Treasurer to keep a just and impartial record of each meeting of the association and Trustees, in a book kept for that purpose. He shall receive all moneys from whatever source, and pay none out except by order of a majority of the trustees.

Art. 5 The Annual meeting of the association shall be held the first Wednesday in January, notice of the same shall be posted in the Post Office and Church at least ten days before the time of holding such meeting.

Art. 6 When three or more proprietors present to the Secretary, in writing, an article to be inserted in the call for a meeting, it shall be his duty to insert the same.

Art. 7 If any tree or shrub shall by their roots, branches, or otherwise become detrimental to the adjacent lots or avenues, or inconvenient to passengers, it shall be the duty of the Trustees to cause such trees or shrubs, or such parts thereof as are detrimental or inconvenient, to be removed.

Art. 8. The Trustees may cause all lots to be worked at the expense of the owner of said lot after three months notice from the Secretary.

Art. 9. The Sexton shall receive for digging a grave and filling the same, for persons under ten years, one dollar; ten years or over, two dollars; and shall remove all surplus earth after covering the grave.

Art. 10 at any meeting of the association five shall constitute a quorum; a less number may adjourn.

Art. 11. These bylaws may be altered or amended at any annual meeting by a vote of two-thirds of the proprietors present, notice of such alteration or amendment having been given in the call for the meeting.

Art. 12 Lots in this Cemetery shall be held subject to the provisions contained in the Public Statutes of Massachusetts concerning Cemeteries.
