PRELIMINARY TAX AMOUNT: As a general rule, your preliminary tax will not exceed 50% of your <u>adjusted</u> fiscal year 2022 tax (including any betterments, special assessments and other charges added to the tax). Adjustments are made for abatements or exemptions granted for fiscal year 2022, and tax increases allowed under Proposition 2½ in fiscal year 2023. Under certain circumstances, your preliminary tax may exceed 50% of the adjusted amount.

PAYMENT DUE DATES/INTEREST CHARGES: If preliminary bills were mailed on or before August 1, 2022, your preliminary tax is payable in two equal installments. Your first payment is due August 1, 2022, or 30 days after the bills were mailed, whichever is later. Your second payment is due November 1, 2022. However, if preliminary bills were mailed after August 1, 2022, your preliminary tax is due as a single installment on November 1, 2022, or 30 days after the bills were mailed, whichever is later. If your payments are not made by their due dates, interest at the rate of 14% per annum will be charged on the unpaid and overdue amount. ## IMPORTANT INSTRUCTIONS REGARDING THE ENCLOSED MOTOR VEHICLE EXCISE TAX BILL

Do not ignore this bill even though you may have moved, sold, traded, or otherwise disposed of the vehicle which this bill represents.

If this bill remains unpaid and outstanding after the due date, it will continue to accrue interest and other charges and fees for which you will be responsible. Your driver's license and/or vehicle registration will also be submitted to the Registry of Motor Vehicles for non-renewal action.

If you have questions, please contact the Board of Assessors at the City/Town from where the Excise Bill is rendered.

#### Note:

Partial payments <u>can not</u> be accepted. <u>PAYMENT IS CONSIDERED MADE WHEN RECEIVED BY THE COLLECTOR.</u> An Application for Abatement does not stay collection of the Motor Vehicle Excise Tax.

Timely payment made by due date of this bill will avoid all interest and other additional charges and fees.

In the event an abatement is granted due to sale, trade, theft, total loss, or overvaluation, the amount abated will be refunded to you.

(Mass. Gen. Laws Ch 60A) No abatement shall be granted for less than \$5.00, and no amount shall be refunded below \$5.00. Applications for abatement must be filed no later than 3 years after the excise is due, or one year after the excise is paid, whichever is later.

## NOTICE

You may be entitled to an abatement (or refund if the excise is paid) if:

- (1) your vehicle is valued for more than percentage of manufacturer's list price in the schedule established by G.L. Ch. 60A §1.
- (2) your vehicle is exempt from the excise under G.L. Ch 60A §1.
- (3) you sell, trade or otherwise transfer ownership of the vehicle, and transfer or cancel your registration, during the same calendar year.
- (4) you move to another state, register the vehicle there and cancel or not renew your Massachusetts registration, during the same calendar year.
- (5) your vehicle is stolen, you report the theft to the police within 48 hours, and you cancel your registration and obtain a certificate from Registrar at least 30 days after theft.
- (6) you register the same vehicle again later in the same calendar year.

You are not entitled to an abatement if you (1) cancel your registration and retain ownership of the vehicle, or (2) move to another Massachusetts city or town, during the same calendar year.
