3. Regional Agreement Article for Chatham and Harwich Town Meetings

Chairperson Nancy Scott advised the committee that through an oversight, the Town of Chatham did not include the amended regional agreement on their annual Town Meeting Warrant for 2018. It does appear on the 2018 Harwich Town Warrant. It is necessary for the school committee to officially request that the regional agreement article be indefinitely postponed on the 2018 Harwich Town Warrant. The regional agreement states that both towns must vote on any amendments at their annual town meetings. The school committee will seek to amend the regional agreement at the 2019 Chatham and Harwich Annual Town meetings.
