#### EXTRACTS FROM GENERAL LAWS, CHAPTER 140, AS AMENDED

Section 55. Whoever acts as a collector of, dealer in or keeper of a shop for the purchase, sale or barter of junk, old metals or second hand articles without a license, or in any other place or manner than that designated in his license or after notice to him that his license has been revoked, or violates any such rule, regulation or restriction, shall forfeit twenty dollars. The purchase, sale or barter of books, prints, coins or postage stamps shall not be deemed to be the purchase, sale or barter of second hand articles within the meaning of this and the preceding section.

Section 56. A junk collector shall be deemed to be any person who by going from place to place collects by purchase or otherwise junk, old metals or second hand articles, whether or not by previous contract or arrangement.

Section 202. Licenses granted to keepers of intelligence offices, dealers in junk, old metals and second hand articles, junk collectors, pawn brokers and keepers of billiard saloons, pool or sippio rooms or tables, bowling alleys, skating rinks and picnic grounds shall, except as hereinafter provided, be signed by the clerk of the town where they are granted. Every such license shall, before being delivered to the licensee, be recorded by the town clerk, in a book kept for that purpose. Such license shall set forth the name of the licensee, the nature of the business, and the building or place in such town in which it is to be carried on, and shall continue in force until May first following unless sooner revoked. The board or officer issuing such a license shall, except as provided in section seventy-seven, receive for the use of the town such amount, not less than dollars for each license, as the board or officer considers reasonable.\*\*\*\*

Section 203. Such licenses may be granted in April, to take effect on May first following.

Section 204. A license issued as aforesaid shall not protect the holder thereof in a building or place other than that designated in the license unless consent to removal is granted by the licensing board or officer.

Section 205. Upon the revocation of such a license, such clerk shall note the revocation upon the face of the record thereof, and shall give written notice to the licensee by delivering it to him in person or by leaving it at the place of business designated in the license.

Re: Friends of the Harwich Council on Aging, Inc. v. Attorney General and the Harwich Council on Aging

Dear Mr. Clark:

You have requested that I review the draft *cy pres* petition which the Friends of the Harwich Council on Aging ("Friends") is intending to file in the Barnstable Probate and Family Court. Counsel for the Friends has forwarded to me a copy of the draft complaint, a copy of which is attached, and has requested that the Town consent to the entry of the proposed judgment that is attached to the complaint.

My understanding from reviewing the draft complaint is that since the late 1980's, the Friends has been conducting fund raising activities in order to raise money for a senior center to be constructed on land owned by the Town in Harwich. There is no record, however, of the individual donors who have contributed the funds and no record of any express restrictions on the use of monies donated to the Fund. At the present time, the Fund has grown to approximately \$700,000.

Apparently, the original intent of the Friends was to use the donations to construct a senior center on land to be donated by the Town. It is my understanding, however, that the Town decided not to donate the land to the Friends, but instead constructed a senior center using Town appropriated funds. According to the complaint, while the Friends sought to donate the money to the Town for the purpose of contributing to the renovation of the Senior Center, Town Meeting rejected the renovation plan.

In its complaint, the Friends represents that since there is no longer a need for funds to renovate the Senior Center, the Friends would like to change the purpose of the donated funds to allow the funds to be used to provide a variety of services to seniors through the Council on Aging while leaving open the possibility that the funds could also be used in the future to renovate or enhance the existing space that the Council on Aging utilizes to provide its programs. Please see the specific proposed re-purposing of the funds set forth in the proposed judgment attached to the draft complaint.

In my opinion, the funds received from the fundraising activities of the Friends constitute a charitable trust which generally means that the monies can only be used for the purposes for which the funds were donated. In order to change the purpose, the Friends are required to seek court approval for the re-purposing of the funds under the so-called cy pres doctrine. In my opinion, the Friends is following the correct legal procedure to obtain court approval for the re-purposing of the funds. Because the Division of Public Charities of the Attorney General's Office has jurisdiction to ensure that charitable trusts comply with the law, the Friends has also named the Attorney General, along with the Town of Harwich, in the complaint. The issue for the Town to determine is whether the Town is in agreement with the proposed re-purposing of the gifts funds since the Friends will be seeking a consent from the Town as well as the Attorney General.

I recommend that this matter be brought to the Board of Selectmen, and if the Town has no objection to the re-purposing of the funds as proposed, I recommend that Town Counsel to sign the consent on behalf of the Town.

Thank you for your efforts to help us gain the Board of Selectmen's assent to our efforts to re-purpose the Friends' fund to allow us to spend the funds on areas that benefit Harwich's Seniors. The BoS assent will add its support to that of the COA Board, and the AG's Office as we proceed to the Probate Court where our case will be heard and, hopefully, be approved.

I want to make a couple comments:

As I mentioned to you some time back, there has been, and there is, no "Trust" that was set up for these monies. Successive Boards of the Friends have none-the-less treated the funds as if it were in trust. It has been zealously held tightly since day one, and remains so today. It has also been invested quite conservatively. even while invested quite conservatively, the fund has grown tremendously.

As there is no ""Trust" may I suggest the following statement be considered for the BoD motion and vote:

"I move that the Harwich Board of Selectmen authorize filing an assent to Petition filed by the Friends of Council on Aging seeking approval to repurpose previously collected funds from use for construction of building to program support."

If you choose not to change the language, Atty. Giorgio's terminology (I assume it is his) will work for what we are trying to accomplish.

### Parties

Plaintiff Friends Of The Harwich Council On Aging,
 Inc. ("Friends") is a non-profit corporation organized under the
 laws of the Commonwealth of Massachusetts and has its principal
 place of business at 100 Oak Street, Harwich, Massachusetts.

2. Defendant Attorney General of the Commonwealth of Massachusetts has a principal place of business at One Ashburton Place, Boston, Massachusetts and is a necessary party to this action pursuant to Uniform Probate Court Practice XXXIV: Charitable Interests.

3. Defendant Town of Harwich ("the Town"), acting through its Council On Aging ("COA"), is an interested party with respect to the matters raised herein.

### Background

 Friends was organized in 1974 under the name of "Friends of Albro House, Inc."

5. In 1975, Friends' Articles Of Organization were amended, and as so amended, now provide the following description of the purpose for which Friends is organized:

The Corporation is organized exclusively for charitable and educational purposes, including, for such purposes the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code of 1954 or the corresponding provisions of any further United States Internal Revenue Law. These programs also include the following: To provide facilities, programs, counseling, and assistance of every nature and kind relating to, and for the use and benefit of, the Senior Citizens of the Town of Harwich, including assisting in the operation of the Harwich Council On Aging; to apply for grants, enter into contracts, receive funds from public and private citizens; to acquire or lease property, both real and personal by purchase, gift, devise, or grant, and to maintain, sell, lease or mortgage said property in order to attain the purposes of the Corporation.

6. Commencing in the late 1980s, Friends began raising funds ("the Fund") through a variety of efforts, including, for example, bake sales, for a senior center to be constructed on land owned by the Town in Harwich.

7. There is no record of the individual donors who contributed to the Fund during the period of active fund raising and no record of any express restriction on the monies donated to the Fund; in particular, there is no restriction that the

monies so donated be used solely to construct a senior center and for no other purpose.

8. Since this effort began, the Fund has grown to approximately \$700,000 as a result of conservative investments by Friends.

9. Subsequent to Friends' fundraising efforts, the Town determined not to donate the land on which it had been anticipated that the senior center would be constructed.

10. Also subsequent to Friends' fundraising efforts, the Town constructed a community center which has housed the COA since its construction.

11. For the past several years, Friends has investigated whether and to what extent the COA needed additional and/or new space for which the Fund could be used.

12. In 2013, Friends and the Town entered into a memorandum of understanding pursuant to which Friends would allocate funds to finance a portion of the Town's proposed renovations to the community center, namely to build a senior lounge.

13. At town meeting, the voters rejected the Town's plan to renovate the community center, which would have included the senior lounge.

14. Because there is no longer a need for funds to construct a senior center (the Town-owned land is no longer

available, the COA has space in the community center, and the effort to renovate the community center was rejected by the voters), Friends desires to repurpose the Fund to support Harwich elder citizens and the COA as follows: (1) to provide emergency assistance for food, fuel, medical needs and/or minor emergency home repairs, as requested by the director of the COA; (2) to provide medical equipment such as incontinence products, canes and bed railings, as requested by the COA's director; (3) to support meal programs, holiday meal packages, and supermarket gift cards; (4) to provide transportation assistance by financing and running a minibus; (5) to support socialization programs such as dances, concerts, educational programs, etc.; (6) to pay for equipment that supports music appreciation, such as a new piano, and awareness of current events and entertainment, such as a new TV; and (7) to consider future needs of the COA, including the need to renovate or enhance its existing space, that are not eligible for funding from other sources.

### Count I

15. Plaintiff repeats and re-alleges each and every allegation above as though fully set forth herein.

16. The cy pres doctrine applies to gifts to charitable corporations. Smith v. Livermore, 298 Mass. 223 (1937).

17. A liberal construction is to be given to charitable donations, with a view to promote and accomplish the general charitable intent of the donor. <u>Rogers v. Attorney General</u>, 347 Mass. 126, 131 (1964).

18. Plaintiff requests that this Court apply the cy pres doctrine to repurpose the Fund as described above and as set forth in the proposed form of judgment attached hereto as Exhibit A, or in such other way that this Court deems will accomplish the general charitable purpose of the donors as nearly as it can be conveniently done.

### Count II

19. Plaintiff repeats and realleges each and every allegation set forth above as though fully set forth herein.

20. Alternatively, plaintiff requests that this Court instruct it as to how to dispose of the Fund in conformity with plaintiff's fiduciary duties.

WHEREFORE, plaintiff Friends Of The Harwich Council On Aging respectfully requests this this Court enter a judgment:

a. On Count I, applying the cy pres doctrine to repurpose the Fund as set forth above or as this Court deems proper;

b. Alternatively, on Count II, instructing plaintiff as to how to dispose of the Fund in conformity with its fiduciary duties; and

c. Grant such other and further relief as this Court deems equitable and just.
