Attendees may ask questions and discuss similar efforts on Cape Cod.
4. **Using Community Preservation Act (CPA) for Historic Preservation Projects:** Attending members of Cape town Historical Commissions and Commission staff will discuss projects that are eligible for CPA funding, requirements for Preservation Restrictions on buildings that receive CPA funding, and share success stories and questions on historic preservation projects.
