Mr. O'Malley,

We did enforcement checks last week and noticed that the 20' Grady White was on your mooring in the Herring River (#409). When we checked the boat registration we notice that it is still registered to Fergal Brennock. For the past several years, both myself and Michelle have sent you multiple emails (many attached) to let you know that our regulations require that the boat be registered to the mooring permit holder, yet you continue to disregard the regulation. In addition, as you know our regulations also require that mooring permit holders use their moorings for a minimum of 30 days during boating season (Memorial Day to Columbus Day) with a boat registered in the name of the mooring permit holder. So to be clear, the 20' Grady White that is registered to Fergal Brennock and currently occupying your Herring River mooring does not meet the 30 day mooring occupancy requirement. You must have the boat registration changed to your name prior to Sep 11 in order to comply with the 30 day use requirement, or your mooring permit will be revoke at the end of the season.
