Since Sep 2017 you have been notified on several occasions by this office of the need to have the Grady White registered in your name as the mooring permit holder, as evident from the attached emails. I understand that it has become more difficult now that the office is closed due to the pandemic, but you've had several years now to correct the issue. I will have Michelle process your mooring permit payment, however, if you do not meet the 30 day mooring use requirement in the upcoming boating season with a boat that is registered in your name as the permit holder, then your mooring permit will be revoked at the end of the season, which is Columbus Day weekend. It will be your responsibility to provide this office with a current boat registration that is in your name. Stated regulations are outlined in the Harbor Management Plan, which you can view on the town website. Thank you. regards,
