### **Director's Report- Commission Meeting 3-23-21**

- ◆ Whitehouse Field Lighting Project There will be a bid opening for the lighting project based on the RFP issued by Town Administration on Thursday March 18<sup>th</sup>. The project seems to be moving forward. I will update the commission at our meeting on the bid opening results.

  Director shared the results of the bid opening for the Whitehouse Field Light Installation as well as the overall budget for the project. John Mahan asked that the Director email a copy of the budget for the project to all Commission members.
- ♦ Whitehouse Field Scoreboard Project A contract has been issued for the procurement of a new scoreboard for Whitehouse Field. Part of the funding for this project, as well as, the lighting project will be paid for by the \$75,000 donation from the Harwich Mariners.
- Sand Pond Restroom I am currently putting together a draft RFP for the Sand Pond Restroom project to submit to Town Administration for their review.
- ◆ FY2022 Budget Hearing I had a budget hearing with the Board of Selectmen and the Finance Committee on March 12 where I reviewed our FY22 budget. There were very few questions and the boards seemed happy with our submittal.
- ◆ Finance Committee Project Meeting I presented this year's three CPC projects that will be on the warrant for the May Town Meeting to the Finance Committee for their approval/recommendation on March 11. The Finance Committee voted to approve all 3 of our projects unanimously.
- Spring Programs We will be running a slate of outdoor spring programs that will begin in April and we are already starting to see very good registration numbers.

◆ Summer 2021 Programs - We are working on our summer brochure for 2021 and we are happy to have a semblance of programming back this summer. We will be offering a scaled back

version of our normal summer full day playground program and summer ball programs. We do not plan to offer swimming lessons because social distancing and mask wearing are not possible in this type of program.

◆ Summer Beaches 2021 - We have emailed out our invites to returning staff for this upcoming beach season. We are planning on having a full beach staff and also hope to re-open the full parking of at Pleasant Road Beach and resume selling daily passes there this summer which will significantly increase daily pass revenue for the Town. I am in consultation with the Health Department regarding beach corona monitors and early response looks like we will have some corona monitors but not to the extent that we did last summer.

Property Maintenance Report - A current maintenance report was given to Commission Members. Budget Reports - A current budget report was given to Commission Members. Chairman's Report -

- John Mahan told members that Brooks Park Baseball Field is being worked on by the Highway Department to ready it for the upcoming season.



# BEACHES, PLASTIC, and LIFE



An artistic display of the variety and amount of "found" plastic on Cape Cod beaches

### **OBJECTIVE**

At public beach entrances install display cases showing art collages of found beach trash. This helps remind us and visually informs us that our beaches are littered with waste, litter, and marine debris. All of which have an adverse environmental impact.

Artist, Suzanna Nickerson, creates the displays of found beach trash. Weatherproof wood and plexiglass display cases hold the art work. A descriptive note describing the location, time and date of the found materials is included. The artwork varies in materials and range in size from  $1.5 \times 1.5$  feet to  $4 \times 4$  feet.


### WHAT IS IT?

It has become an unavoidable habit: Chatham and Vineyard artist, Nickerson, walks almost daily picking up litter from our Cape Cod beaches. Sure, it could all be thrown in to a trash can but that does not diminish or eliminate the voluminous physical and emotional weight of finding so much plastic trash on our beaches. Instead, Nickerson, cleans, sorts and then creates artistic collages to remind us of the impact of plastic on our beaches and in Nature.


### WHY?

Over five million tourists visit Cape Cod beaches, ponds and woodlands each year. The Cape Cod National Seashore alone has four million visitors. We are accustomed to appreciating Nature – the beauty around us. But what is it that we see and feel? How focused are we? Do we only see and enjoy the water vistas, the horizon, the rising and setting of the sun or moon? Or do we also see the human impact on Nature?

We propose that a visual prompt could help align our consciousness to our individual actions and behavior. Can we link our visitation spirit with the impact of plastic on Nature? That is the function and purpose Nickerson's art: helping people see the impact of plastic on wildlife and the environment.

### **PROPOSAL**

Working with you, determine display locations, choice of artwork, and specifying display case size and design. Cases can be oriented either vertical or horizontal. Deciding all the details, size, shape, color, etc., can be an interactive process. Each art work collage has a descriptor detailing the work. For example: "All of this trash was picked up by one person in an hour walk on Salt Marsh Beach, January 14, 2021."

The art work, materials, and labor is considered a donation contributed free of charge.


### **SUMMARY**
