CALL TO ORDER

A. Wastewater Discussion

Sewer rates, rules and regulations will need to be ironed out, irrigation meters, the start up of the collection system and how the bringing on and training of contract operators will take place.

Superintendent Pelletier has a meeting scheduled on September 15, 2020 with the Interim Town Administrator regarding the Board of Water Commissioners transitioning to becoming the Board of Water/Wastewater Commissioners.

The Board expressed interest in having all Board members attend future Wastewater meetings with the Town Administrator.

B. Water/Wastewater Commissioner's Role Over Department Employees

The Board would like the language in the Charter to be cleaned up so that the authority of Water Department employees can once again fall under the Board.

NEW BUSINESS

A. FY21 Wastewater Budget

Superintendent Pelletier reviewed the FY21 Wastewater budget with the Board.

B. Laborer Hiring Update

Superintendent Pelletier provided the Board with an update regarding the Distribution Laborer position. There were 26 applicants that applied for the position and interviews will be scheduled shortly.

SUPERINTENDENT'S REPORT

Horsley & Whitten is a firm that has been contracted by the EPA to perform a Cybersecurity assessment at the Water Department.

Saturday, September 26, 2020 is the Annual Town Meeting.

The Department has received the roller. The small trailer has been ordered and is expected to be delivered in October. The larger equipment trailer quotes are due back shortly.

Next week, the Department's digging crew will be on Great Western Rd for the cross-over project.

The Department's annual sanitary and security tank inspections are taking place next Wednesday.
