- Held 6-week training from October 3rd November 7th in Eastham and Harwich. 55 elected and appointed municipal officials and town staff attended. During the Institute CDP and HAC had weekly check-ins and weekly debriefs. Attendees were given feedback forms after each session as well as one longer evaluation form referring to the entire Institute. After the Institute, the CDP reviewed feedback and began planning for 2019.

During this time we also collected their headshots, bios and Speaker Agreements.

- Post-Institute Wrap-Up: New this year, we offered a seventh session on a town-by-town basis to CHI graduates.
 - Met with a consultant about facilitating these sessions.
 - Developed a Design Committee with Lower Cape Town staff to design the wrapups. Convened one in-person and one phone meeting with the Design Committee to get input on goals and structure of the sessions.
 - Held wrap-ups in Provincetown, Wellfleet, Eastham, Brewster, Chatham, Orleans and Harwich.

 - Held Fall Outer Cape Peer Group meeting in Provincetown and Fall Lower Cape Peer Group meeting in Chatham. Held Winter Outer Cape Peer Group meeting In Eastham and Lower Cape Peer Group meeting in Brewster.
