d) Discussion on creating a written policy for land purchase procedures.

Donna offered steps the CPC could take in creating land acquisition projects procedures:

Look at the town's written policy on land acquisition principals.

Maybe the BOS should provide approval.

Maybe the applicant for a land acquisition project should have a Purchase and Sales agreement.

Kathy offered that the REOS committee has had a written Land Acquisition Policy since 2011. REOS follows a checklist before going to the BOS for approval, then they proceed on the project. A negotiating committee is set up to work on the land purchase.

Don offered the BOS has now agreed to start with the Town Administration. The Town is the applicant for land purchases. The issue with the Jenkin's property purchase was it wasn't clear who was going to purchase the land until the day before Town Meeting. The warrant article was changed by legal along the way; it got away from them. This is a problem.

Elizabeth agreed a policy is needed.

Bob offered in addition to a policy, legal counsel could review the project before the CPC votes on it.

John offered it is important to have well defined written policies and good communications.

Dave suggested speaking with the BOS Chair regarding the town's legal counsel firm, KP Law. He offered the CPC may want their own legal counsel. Legal review of land purchases focused on the CPA guidelines may be a different viewpoint from the town's review of land purchases guidelines.

Kathy reminded the committee it was the applicant of the Judah Eldredge land acquisition project that brought in the legal opinion to the CPC while the project was being vetted.

Elizabeth offered the CPC should be able to check with a lawyer to review things under Community Preservation Act law.

Dave offered there is money in an account to handle this. He reminded the committee that we don't know what the projects are until they are submitted.

Kathy suggested changing the submission deadline to Sept. 1, allowing more time to vet the projects.

Joseph asked what are the committee's next steps?

Donna suggested creating a small working group of joint committee members to work on these ideas. Members from the CPC, BOS and REOS could get together.

Kathy (REOS), John (Conservation), and Mary (Planning) are the CPC representatives to serve on the working group. They have the area of experience to add to this group.

Donna asked if the Town Administration and the CPC Chair be on the working group? She offered to assist the working group in an advisory capacity.

Don offered to get the BOS input on the working group and their working group representatives.
