Gayle Carroll: appoints alternate Patricia Scarnici with full member voting rights for this meeting

and reads the case presented as follows:

**HH2015-12 Notice of Intent** (NOI) Demolish a structure over 100 years old has been received for property located at 177 Forest Street, Map 31, Parcel C2, in R-L Zone pursuant to the Code of the Town of Harwich §131-8. The Applicant proposes a partial demolition of the c. 1828 main home. Owner, Steven Szafran

Discussion on how Mr. Szafran intends to protect the main house.

Steven Szafran: explains how he will protect the main house while maintaining access, offering that he will use a 6 millimeter sheet of plastic and use strapping to nail the plastic in place. States no one has lived in the main house for 20 years year-round, only summers.

Bob Bradley questions this plan, asks members if they agree that this method is sufficient, and why he is in a rush to tear it down.

Gayle Carroll: questions if this method is real protection

Jeanne Steiner: questions if this method would stand up to the winter months

Mr. Szafran: I have used this method before and it was successful.

Mr. Bradley makes a motion to move forward with a vote. Seconded by Barbara Dowd.
