#50 OPEB Trust Fund - revise to \$53,000 from \$25,000

STM

#2 Fund Shortfalls in Budget Transfers - \$200,000 for DPW, \$120,000 coming from Health Insurance/ \$30,000 from Police SW, \$30,000 Fire S&W, \$20,000 coming from ambulance S&W
