A special Board meeting will be held on March 6, 2018 to review the solar contract.

Verizon is interested in constructing a monopole on Water Department land located at 196 Chatham Road. Superintendent Pelletier will supply Verizon with a map of their site options.

Lower County Road Water Main Improvements project will soon be put out to bid.

The Water Department is interested in going to quarterly billing. The consulting company, Tighe & Bond will be contracted to perform a water rate study prior to the Department moving to a quarterly billing structure.

The Board reviewed a real estate open space map to begin searching for land for well exploration. It was suggested to pursue land north of the watershed.

Superintendent Pelletier provided an update on the new SCADA system.

Superintendent Pelletier discussed the possibly of adding fiber optics to the Route 39 tank in the future.

The Water Commission will attend the joint meeting with the Board of Selectmen and Finance Committee on Saturday.

The Board will meet again on Wednesday, March 6, 2018.
