
Capital Project:

Mr. Greer, Mr. Smith & Mr. Fernandez met with Mr. Clark, Mr. Libby and Mr. Cafarelli on June 6th to get more of an idea of where things stand and what the next steps are to be. Mr. Smith and Mr. Greer will look into getting information on the Butler Building. They will have another meeting this coming Monday.

New Business:

• Tee Time Allocation & Analysis – Roman Greer

- The primary reason for the block times is to protect member tee-times. We are lucky to get a lot of bookings from public/hotels in the off-season. With blocks in place the member tee times are protected and the public are directed to the appropriate block.
- The size of the morning block is designed to accommodate a large group of members before any guest groups arrive. In speaking with members and other municipal courses on Cape, there is a lot of value in having a "members only" experience in the morning where they are guaranteed not to be behind vacationing public and among fellow members. The balancing guest block is large enough to accommodate our regular guest groups (many groups requiring well over 1 hour worth of tee-times) without having to "borrow" member tee-times, as was past practice.
- Through the system began in 2015 of opening unsold tee-times to members the evening before play on the Chelsea System, there should be ample opportunity to grab tee-times in the morning non-member block as well. In 2015 over 60% of rounds played at CV were played by members, many utilizing this system.
- This email was sent out to all members this winter in regards to this new tee sheet change

Public comment:

Mike Gardiner - thanked the committee for their prompt response to his concerns and was generally satisfied with the data that had been provided at the meeting by the Director.

Bill Burke – Asked the committee what the role of the Golf Committee and who is in charge? Ms. Duffy answered that the Committee is a Policy making committee and has no direct role in the everyday running of the course. That is Mr. Greer's job. The committee does not do his yearly evaluations or have anything to do with the seasonal employee's. Mr. Smith added that additional responsibilities include oversight of the operation and recommendation of rates and fees.

Connie Mahady asks Mr. Greer to review the release of the unused non member tee times the night before. Mr. Greer states that at about 6:00 pm

when the Pro shop closes a majority of the unsold nonmember tee times will be changed to member times so members can use them.

Jack Connolly asks if there is a Jr. rate for nonmembers and if not if that could be considered for next season. Mr. Greer states that has been a discussion and will be looked at again this November when rates are set.
