HEARINGS

NOTICES OF INTENT

6:30 <u>Rupert L. Nichols Family Limited Partnership, 335 Lower County Road, Map 12 Parcels Y1-56, Y2-1 & Y1-57B –</u> Pump existing cesspools and fill with clean soil, Install new tight tanks to service the sanitary sewage flow of the existing buildings. No changes to the buildings are proposed.

Presenter: Daniel Croteau, PE - Moran Engineering Assoc., LLC

Mr. Croteau discussed the project. Board of Health review set for October 18, 2016.

Motion made by Brad Chase to continue 335 Lower County Road project to November 2, 2016. Seconded by Ernie Crabtree. Vote: 4-0-0.

6:42 Terence & Pamela McDermott, 151 Gorham Road, Map 24, Parcel R1-1 – Construction of addition to dwelling within 100' of a cranberry bog.

Presenter: David A. Clark, P.E. - Clark Engineering, LLC

Discussion of project and limits of work and performance standards. No disturbance in the 50' buffer. Mr. Clark said he does not think that the project will impact the vegetated wetland.

Amy Usowski stated that the land adjacent is owned by the Harwich Conservation Trust (HCT) and is an abandoned cranberry bog. The bog is hydraulically connected to Cold Brook which outfalls to Saquatucket Harbor, a tidal estuary. She discussed recalculation for planting mitigation. She said mitigation is left up to HCC, and may be put in the Order of Conditions.

Ernie Crabtree asked the reason for expansion. Mr. Clark answered that the applicant needs more family living space.

Discussion of topography and steep slope.

Brad Chase stated that he favors 1:1 mitigation in the 50 to 100' buffer for a total of 16 mitigated bushes.

Motion made by Brad Chase to approve the Notice of Intent for 151 Gorham Road with the Condition of 1:1 mitigation in the 50 to 100' buffer (367 Sq. Ft.). Seconded by Ernie Crabtree. Vote: 4-0-0.

6:44 <u>Gwynne Daks, 18 Harbor Way, Map 1, Parcel C-2-7-0 -</u> Proposed upgrade from existing cesspool to a Title 5 sewage disposal system within the 100' buffer zone to a coastal bank and 200' buffer zone to riverfront area.

Motion made by Ernie Crabtree to continue 18 Harbor Way to October 19, 2016. Seconded by Carolyn Crabtree. Vote: 4-0-0.

Amy Usowski explained the change in plan primarily for the approved porch enclosure to be on crawl space foundation. She recommends approval as a new plan of record.

Motion made by Ernie Crabtree to approve the Change in Plan for 39 Rainbow Way. Seconded by Carolyn O'Leary. Vote: 4-0-0.

7:02 Keith O'Donnell, 55 Sugar Hill Drive, Map 88, Parcel R49 (SE 32-2166)

Presenter: Keith O'Donnell

Mr. O'Donnell explained the request for the extension is due to economic hardship. The septic has been done. He is requesting extension for remodeling and mitigation.

Amy Usowski said she recommends a 2 year extension under the Act and Bylaw.

Motion made by Brad Chase to approve the Extension Request for 2 years under the Act and Bylaw. Seconded by Carolyn O'Leary. Vote: 4-0-0.

Amy Usowski reports that there is quite a required list of mitigation. Deck is long and narrow. Stone retaining walls are working well to prevent erosion. Driveway is pervious. No irrigation as conditioned in 0-50' and 50 to 100' buffer. Ms. Usowski states that old cranberry bog ditch does fill with water. She recommends any irrigation heads come out of 0 to 50' buffer.

Discussion of procedure requiring the removal of irrigation.

Amy Usowski recommends approving Certificate of Compliance with a letter of enforcement and follow up.

Motion made by Ernie Crabtree to approve the Certificate of Compliance for 23 Grist Mill Lane with the issue of Order of enforcement. Seconded by Brad Chase. Vote: 4-0-0.
