Any work within Floodplain or within the 200' Riverfront Area will require review by the Conservation Commission. The floodplain contour snakes through property and building. Any work to improve these structures will need to be less than 50% of the appraised value of the structure, or the entire structure will need to meet FEMA compliance. The 200' Riverfront Area is in the north west corner of the property. Any change to disturbance there would trigger review under the Massachusetts Rivers Act.
