Historic application for Certificate of Non-Applicability

1. **Architectural Trim or Siding** – Replace existing rotted trim and replace in kind with pine trim boards. Replace and patch (as needed) Cedar clapboard siding (front of building) and cedar shingle siding (sides and rear).
2. **Doors** – Replace exterior doors in kind.
(fiberglass/wood)
3. **Gutters** – Replace existing aluminum gutters as needed in kind
4. **Paint Color** – Color match existing yellow paint and paint front of main building and accessory building
5. **Porch/Decking** – Replace decking and railings with PT lumber in kind.
6. **Roof** – Replace entire roof with asphalt roof shingles in kind.
7. **Windows** – Replace windows in main building with Anderson 400 Series. No size changes. No grill pattern changes. No type changes.
