I have reviewed the proposal for a new subdivision located at Off Littlefield Pond Road, Harwich.

At a meeting of the Board of Health on July 9, 2019, the Board unanimously voted to approve the preliminary subdivision plan for 7 lot Of Littlefield Pond Road with the following conditions:

1. The Harwich Board of Health will not consider any variances from Title 5 or Harwich Board of Health Regulations for any of the lots.
2. The lots are restricted to one bedroom per 10,000 square feet.
3. The subdivision will be served by town water.

A complete septic application will be required prior to the sign off of any building permit.
