In reference to PB2021-23 at 254 Queen Anne Rd., the DPW has concerns about storm water management and runoff associated with this project. This property sits in a low area of Queen Anne Rd. with already heavily taxed drainage systems. Any new contribution to these systems would be detrimental and could potentially cause flooding issues not only on the right of way but also private property adjacent to this facility. The DPW has worked to resolve the flooding issues here and hope that any future projects will have considerations for management of their own storm water runoff to prevent a reoccurrence of the problems.
