#### Lifeguards and Gate Attendants

Beaches are staffed 7 days a week, weather permitting, 9:30 am – 4:30 pm. Mandatory workouts for lifeguards are required and are in addition to the operational hours.

#### Lifeguard candidates:

- You are required to demonstrate that your appropriate certifications are current through Labor Day, 09/02/2024 and that all certifications are valid (lifeguard training, first aid and CPR) for the upcoming season.
- This year we will only be offering a recertification class and not a full certification. If your current Lifeguard Certifications are expired or expiring prior to June 18, you must find an outside class that offers American Red Cross Lifeguard Certification.
