HARWICH, MASSACHUSETTS

VOTED: As authorized by the General Laws and the Statutes of the Commonwealth of Massachusetts to adopt the following amendments to the Town of Harwich Traffic Rules and Regulations in conjunction with the Safety Improvement Program (TOPICS):

A. PARKING PROHIBITED

✓ Bank Street: Easterly side from Route 28 to a point 190 feet northerly and from Route 28 to a point 100 feet southerly.

Westerly side from Route 28 to a point 200 feet southerly and from Route 28 to a point 250 feet northerly.

✓ Brooks Road: Westerly side of Brooks Road from Route 28 to a point 190 feet southerly.

Easterly side of Brooks Road from Route 28 to a point 150 feet southerly.

✓ Earle Road: Both sides from Route 28 to a point 200 feet southerly.

✓ Freeman Street: Both sides from Route 28 to a point 140 feet northerly.

✓ Lothrop Avenue: Both sides from Route 28 to a point 250 feet northerly.

✓ Sisson Road: Easterly side from Route 28 to a point 220 feet northerly.

✓ Westerly side from Route 28 to a point 100 feet northerly.

B. STOP SIGNS

To be installed in accordance with permits filed by the Town of Harwich and approved by the Massachusetts Department of Public Works.

C. ONE WAY OPERATION

Location 4 Along the section of Gordon Ritchie Road from
Lower County Road to Belmont Road.

D. MANDATORY LEFT TURN. "LEFT LANE MUST TURN LEFT" SIGN

Location 3E Left for southbound drivers on Sisson Road
into Route 28.

HARWICH, MASSACHUSETTS

Voted: That the Traffic Rules and Orders of the Town of Harwich adopted by the Board of Selectmen on July 1, 1940 and subsequent amendments thereto, be and are hereby further amended as follows:

By adding at the end of Article V, Section 2, Parking Prohibited on Certain Streets, the following new descriptions:

North Road: North of Route 28 for a distance of 600'. No parking both sides.

Gordon Ritchie Road: From Belmont Road to Riverside Drive. No parking both sides.

Riverside Drive: From Lower County Road to end of road. No parking both sides

Grey Neck Road: No parking either side of Grey Neck Road from Lower County Road to Shore Road. Parking will be allowed on the west side of Grey Neck Road south of Shore Road to the beach.

Brooks Road: South of Dunes Road, Parking allowed on west side of Brooks Road only. South of Wequassett to Dunes Road, Parking will be allowed on the east side of Brooks Road only.

Please amend your Traffic Rules and Orders of December 14, 1971

To read as follows:

Voted: That the Traffic Rules and Orders of the Town of Harwich,
Adopted by the Board of Selectmen July 1, 1940 and subsequent amendments
be and are hereby amended as follows:

By adding at the end of Article 5, Section 2, Prohibited on Certain Streets
the following new description..

No Parking on the following streets.
North Road

North of Route 28 for a distance of 600 feet. No parking both sides.

GORDON RITCHIE ROAD

From Belmont Road to Riverside Drive. No parking both sides.

RIVERSIDE DRIVE

From Lower County Road to end of road. No parking both sides

GREY NECK ROAD

South of Shore Road to end of road, Parking allowed on West side
of Grey Neck only.

BROOKS ROAD

1) South of Dunes Road, parking allowed on West side of Brooks Road only.

✓ 2, South of Wequasset to Dunes Road, Parking allowed on the East side of Brooks Road only.

MAIN STREET, HARWICH CENTRE

Amend section 10 of the original regulation to conform to the enclosed diagram of Main Street.

These amendments must be forwarded to the Department of Public Works for approval, then the Highway Surveyor must post and mark the areas so designated.

PARKING REGULATIONS

TOWN OF HARWICH

In compliance with the provisions of Chapter 90, Section 20C, Massachusetts General Laws as amended and accepted by the Town of Harwich under Article 71 at the Annual Town Meeting, March 6, 1969, and by every other power as provided by the said General Laws thereto enabling the Board of Selectmen of the Town of Harwich do and have established the following regulations for parking on the roads hereinafter mentioned and to the extent specified:

- + 1. Bank Street (Lower), Harwichport. From State Highway (Route 28) southerly to Nantucket Sound. No parking on either side of said Lower Bank Street, including the surfaced area of the road and all land within the road lay-out.
- + 2. Bay Road, East Harwich. From State Highway (Route 28) south-westerly a distance of approximately five hundred feet (500). No Parking on either side of said Bay Road, including the sur-faced area of the road and all land within the road layout.
- + 3. Bay View Road, Harwichport. From State Highway (Route 28) south-erly to Davis Lane. No parking on either side of said Bay View Road, including the surfaced area of the road and all land with-in the road layout.
- + 4. Belmont Road, West Harwich. From Gordon Ritchie Road southerly to Chase Avenue. No parking on either side of said Belmont Road, including the surfaced area of the road and all land within the road layout.
- + 5. Braddock Lane, Harwichport. From Lower Bank westerly, southerly and easterly to Lower Bank Street. No Parking on either side of said Braddock Lane. Parking allowed on paved surface only.
- + 6. Brooks Road, Harwichport. From Lower County Road southerly to Nantucket Sound. No Parking on either side of said Brooks Road including the surfaced area of the road and all land within the road lay-out.
- + 7. Deep Hole Road, South Harwich. That portion thereof extending easterly and southerly from Julien Road to Red River Beach. No parking on either side of said Deep Hole Road including the sur-faced area of the road and all land within the road lay-out.
- + 8. Harbor Road, Harwichport. From State Highway (Route 28) south-erly to end of Town Road at Wychmere Harbor Town Landing. No Parking on either side of said road including the surfaced area of the road and all land within the road lay-out.
- + 9. Hersey Road, South Harwich. From Uncle Venies Road westerly to Deep Hole Road. No Parking on either side of said Hersey Road including the surfaced area of the road and all land within the road lay-out.
- + 10. Main Street, Harwich Center. From westerly driveway of Town Of-fice property westerly to Pleasant Lake Avenue. No Parking on either side of said Main Street including the surfaced area of the road and all land within the road lay-out.

11. Neel Road, South Harwich. That portion thereof extending southerly from Walther Road to Nantucket Sound. No Parking on either side of said Neel Road as above delineated including the surfaced area of the road and all land within the road lay-out.
12. Pilgrim Road, Harwichport. From State Highway (Route 28) southerly to end of the road. No Parking on either side of said Pilgrim Road including the surfaced area of the road and all land within the road lay-out.
13. Pleasant Road, West Harwich. From Lower County Road southerly to Town Parking area. No Parking on either side of said Pleasant Road, including the surfaced area of the road and all land within road lay-out.
14. Sea Street, Harwichport. From State Highway (Route 28) southerly to Nantucket Sound. No Parking on either side of said Sea Street including the surfaced area of the road and all land within the road lay-out.
15. Shore Road, West Harwich. Westerly from Grey Neck Road to Pleasant Road. No Parking on either side of said Shore Road, including the surfaced area of the road and all land within road lay-out.
16. Snow Inn Road, Harwichport. From State Highway (Route 28) southerly to Davis Lane. No Parking on either side of said Snow Inn Road, including the surfaced area of the road and all land within the road lay-out.
17. Uncle Venies Road, South Harwich. That portion thereof extending from South Chatham Road southerly to Red River Beach. No Parking on either side of said Uncle Venies Road as above delineated, including the surfaced area of the road and all land within the road lay-out.
18. Wah-Wah-Tay-See Road, Harwichport. From Lower County Road southerly to Nantucket Sound. No Parking on either side of Wah-Wah-Tay-See Road including the surfaced area of the road and all land within the road lay-out.
19. Woodland Road, Harwichport. From Bay View Road westerly to Lower Bank Street. No Parking on either side of said Woodland Road, including the surfaced area of the road and all land within the road lay-out.
20. Wyndemere Bluffs Road, Harwichport. From Lower County Road southerly to Nantucket Sound. No Parking on either side of said Wyndemere Bluffs Road, including the surfaced area of the road and all land within the road lay-out.
21. Earle Road, West Harwich. From Lower County Road southerly to the Parking Lot at Earle Road Beach, east and west sides of Earle Road, including the surfaced area of the road and all land within the road lay-out.
22. Silver Street, West Harwich. No Parking on west side of Silver Street from State Highway (Route 28) southerly to Willow Street.
23. Vacation Lane, Harwich. From Queen Anne Road southerly and easterly to Dunworkin Drive. No Parking either side of said Vacation Lane including the surfaced area of the road.

24. Pleasant Park Road, East Harwich. Westerly side of Pleasant Park Road, 259.18 feet in from Queen Anne Road and following the radius of the road for a distance of approximately 260 feet more or less.

These regulations shall remain in full force and effect until such time as they are modified, rescinded or otherwise changed by order of the Selectmen of the Town of Harwich, and during such times as the signs governing parking in the designated areas continue to be installed and displayed.

Violations of these regulations shall be punished by a fine of five (5) dollars; and enforcement of such regulations shall be in accordance with the provisions of Chapter 90, Section 20C of the General Laws as amended.

The Board of Selectmen of the Town of Harwich respectfully request the Department's approval of the following regulation made by the Selectmen on April 7, 1958.

Traffic Rules and Orders, Article 5, Section 2.
Prohibited on certain streets. Upon the following streets or highways or parts thereof parking is hereby prohibited.

Pleasant Road, West Harwich; both sides, from Lower County Road south to Shore Road.

Grey Neck Road, West Harwich; both sides, from Lower County Road south to Shore Road.

Marle Road, West Harwich; both sides from Route #28 south to Marle Road Beach.

Brooks Road, Harwich Port; both sides from Lower County Road south to Dunes Road.

Bank Street, Harwich Port; both sides, from Route #28 south to Bank Street beach.
