I was the engineer asked to look at the Kendrick Rd/Rte. 28 intersection and the first thing I looked at was safety. The records do not show this intersection as dangerous however the design is unusual and should be considered for reconfiguration similar to what was proposed by the East Harwich Community Association. The issue is that there are other intersections that have a more significant crash history and I cannot recommend that this intersection deserves funding for improvements before more hazardous locations, especially in these times when we have limited resources.

I would be happy to meet with you and others interested in making improvements to Kendrick Rd/Rte. 28 and explain my recommendation.

Hi Clay,

The parking restrictions for one side of the street are recommended to prevent the reduction of the travel lane, prevent the obstruction of line of sight, and prevent parking too close to an intersection. The intersection is in proximity to a Town boat landing and the area experiences the overflow of parking. The proposed parking restriction on the northwest side of Kendrick Road may be more appropriate for the southeast side due to the terrain of the northeast side. Please check this during your site visit. I will meet you there to review these proposals if you so notify me.

The Committee has also submitted a recommendation to the Board of Selectmen for On Street Parking Guidelines. These recommendations were offered during the review of an unrelated issue. The Committee developed the guidelines to address safety issues and avoid the political issues that arise from parking regulation

requests.

The Committee has researched the various traffic regulations adopted over the years and has submitted a draft proposal to the Board of Selectmen that reorganizes the regulations into a Municipal Traffic Code. I have sent you a separate email with an invitation to share these files with you (and to those who have received a copy of this email). I have used a Dropbox service for this purpose. I believe you will have to register with Dropbox to access these files. All of the documents are connected to the Table of Contents. If you cannot use Dropbox, I have the files on a disc for you.
