Dear Mr. Raneo:

Upon complaint of several residents of the Park Street/Ocean Avenue area of Harwich Port relative to traffic and safety concerns, the Board of Selectmen referred the matter to Chief William Greenwood of the Police Department for investigation and recommendations.

At a Public Meeting of the Selectmen held on Tuesday, September 1, 1992, Chief Greenwood's recommendations were reviewed and considered. Based upon these recommendations, the Board then voted to authorize the following installations at these locations:

- A four-way stop sign at Ocean Avenue/Park Street.
- 2. A stop sign on Main Street.
- 3. A stop sign on Union Street at Central Avenue
- A "Children" sign on Zylpha Road.

The Board further voted that the "No Parking" sign which had been removed from the right side of Ocean Landing be replaced.

We have also enclosed a copy of a plan submitted by the residents of the area with their letter of complaint and petition. Thank you for your cooperation.

We, the undersigned, respectfully request to be placed on the agenda for the next meeting of the Board of Selectmen scheduled to take place August 18, 1992.

Attached is a petition requesting the installation of two stop signs on Park Street where it intersects with Ocean Avenue in Harwich Port, MA, thus making this busy intersection a four-way stop.

This is a very busy and dangerous area in the summertime. As you are aware the area known as "The Campgrounds" in Harwich Port is densly populated. At all times of the day and evening there is a high concentration of pedestrian traffic as well as people on bicycles, skateboards, roller blades, big wheels. There are many elderly and handicapped people, joggers, as well as children from toddlers to teens, out and about at all times. We feel that any and all measures that can be taken to insure the safety of the population must be taken immediately.

The homeowners who occupy the properties on the four corners of the Ocean Ave. and Park St. intersection continuously witness near-tragic occurances. A four-way stop would go a long way towards insuring the safety of the people in this community.

While obtaining signatures on the petition from homeowners in the area there was overwhelming frustration regarding the excessive speed limit, lack of stop signs on the connecting side streets and absence of "children playing" and pedestrian warning signs.

We respectfully request that whatever studies or surveys necessary to bring about a reduction in the speed limit and the erection of appropriate signs be conducted at a time of heavy summer occupancy (June, July, August).
